## ABOUT WINDING TRAILS

Winding Trails, Inc. is an independent, 501 (c) 3 non-profit organization located in the heart of the Farmington Valley. 350 acres of prime woodland, bubbling brooks and recreational facilities comprise some of the finest facilities in New England.

The main beach area at Dunning Lake has two playscapes, picnic tables, barbecue grills, volleyball courts, basketball courts, bathhouse and boathouse.

The Walton Pond area includes ice-skating complete with a warming hut; preschool, nature and archery programs. The remaining two thirds of the park are left natural for your overnight camping, hiking and cross-country skiing enjoyment.

Our 11-acre Sportsplex includes a softball field, soccer field, three basketball courts, horseshoe pits, three sand volleyball courts, two bocce courts, four tennis courts and a playscape. A large hill is available for winter sledding.

Members receive our quarterly newsletter packed with programs for preschoolers, youths and adults which take advantage of our facilities year-round.

## WINDING TRAILS: FIVE AREAS OF CONCENTRATION

**Membership Program** The facility is open only to its membership for most activities. Families pay a yearly fee that entitles them to use the facility and to register for the programs offered. Membership is limited to 1500 families and we utilize a wait list. Members enjoy activities such as swimming, picnicking, cross country skiing, ice-skating, fishing, special activities and programs.

**Summer Day Camp** The camp, established in 1947, offers campers from ages 3 to 13 over twenty different summer activities. The camp is open to the public; however, members receive a discount on the fees.

**Group Outing Program** Each year over 300 groups rent the facility for company outings, family reunions and weddings.

**Cross Country Skiing** We are an authorized Rossignol Demo Center with over 200 sets of skis, a retail store, ski instruction, and a snack bar. The 12 miles of trails are machine groomed on a daily basis. The ski center is open to the public, but members ski free.

**Special Programs** Throughout the year, Winding Trails offers a variety of programs for its members such as skating lessons, family skating parties, evening ski tours, Touch-a-Truck day, StreetWolves rollerhockey league, mountain bike races, a fishing derby, holiday programs, preschool programs, sports, nature and educational programs, and more.
